

RCR ARENA
WAIVER AND RELEASE

This Document affects your rights. Please read it carefully!

1. I agree as consideration for participating in the activities at the RCR arena Paso Robles, CA (the "Property") that I will strictly observe all state laws and regulations pertaining to the care and treatment of animals.
2. I understand that this Property consists of privately held parking, arena and grounds which do not comply with the safety requirements usually associated with public facilities. I have inspected the Property and accept the property in an "as is" condition.
3. I understand that being in the immediate area of and/or riding horses and working with cattle is a dangerous activity. That there may be hidden hazards, including but not limited to dangers such as dogs, rocks, holes or slippery ground conditions on the Property which may cause either myself or my animal to fall resulting in injuries. I understand and accept those risks of injury to myself and my animals.
4. I also understand and accept those risks of injury to my self or my animals associated with equestrian competitions such as team roping including my animal tripping, falling or rolling over me while competing or the danger of being entangled in or falling upon the arena fence.
5. The Property is located in an environment containing poisonous snakes, brush and cactus. I understand and appreciate that either myself or my animals may be bitten by snakes, caught in the brush or exposed to cactus which could result in serious and life threatening injuries.
6. I appreciate that the activities at the Property may involve working with and among wild cattle and untamed horses. I understand and appreciate that that all animals are prone to, kicking and bucking and that there is a constant danger of falling or being bucked off of the animals resulting in severe personal injuries. In addition I understand that I may be gored by, run over by, bitten by, kicked by, rolled upon and crushed by animals while on the Property. In addition there may be trespassers, or other risks that may frighten the animals to flight and cause death and/or serious bodily injury to my self or my animals. Having inspected the property, I knowingly assume all these risks as my responsibility without recourse against the owner property RCR Rental Company, LLC, Scott and Melody Hutchins, [REDACTED] and any officers, employees, entities, or others associated with or employed by these persons or entities including any trusts.
7. I agree to restrict my activities to the arena and the immediate area surrounding the arena (within 90-feet of the arena). I understand that the roads and surrounding grounds are owned/leased by others and that entering onto the property outside of the immediate area of the arena will be trespassing for which I may be prosecuted and additionally my right to participate in the equestrian activities will be terminated.
8. By signing this Waiver and Release, I acknowledge that I have inspected the Property and assume all risks in using the Property and will hold harmless, protect and indemnify the individuals listed in paragraph 6, their officers, directors, employees, agents, heirs and assigns. I will protect these individuals from and against all claims of injury, loss, damages, liabilities or other expense whatsoever, resulting from my use of the Property or for any damages or injuries sustained by me or my animals, my property or the person or property of any of my guests regardless of the type or cause of the injury.
9. As a condition of this Waiver and Release I agree to inspect, in advance, the Property and the animals. This inspection shall be for the purpose of insuring that the condition of the Property and the animals are fit for their intended use. I further agree that I shall report any unsafe condition immediately to the individuals listed in paragraph 6 and agree not to use the property or the animals if any unsafe condition exists.

THE UNDERSIGNED ACKNOWLEDGES THAT HE / SHE HAS READ THIS AGREEMENT AND HAS HAD AN OPPORTUNITY TO REVIEW THIS DOCUMENT WITH AN ATTORNEY AND IS SIGNING THIS AGREEMENT VOLUNTARILY WITH FULL KNOWLEDGE OF THE RISKS THEY ARE ASSUMING AND THE INDEMNIFICATION THEY ARE UNDERTAKING.
